#### FUNCTIONS OF THE GOVERNING BOARD:

Review and approve strategic and annual work plans that are prepared and submitted to the Governing Board by the participating units.

1. Receive and review annual progress reports submitted by the participating units.
2. Provide feedback and direction to these participating units, as needed, about the various research and extension activities being carried out within the district.
3. Receive and allocate project funds to carry out priority research and extension related activity (e.g. organize farmers) strictly as per the guidelines.
4. Organization and development of farmers interest groups (FIGs) and farmers organizations (FOs) within the district.
5. Facilitate the greater involvement of private sector organizations NGO's in providing inputs, technical support, agro-processing and marketing services to farmers.
6. Encourage agriculture lending institutions to increase the availability of capital to resource poor and marginal farmers especially SC/ST and women farmers.
7. Encourage line departments, KVKs and ZRS to establish farmers advisory committee to provide feedback and input into the respective research and extension programme.
8. Enter into contracts and agreements to promote and support agriculture development activities within the district.
9. Identify other sources of financial support that would ensure the financial sustainability of the ATMA and its participating units.

10. Establish revolving fund/accounts for each participating unit and encourage each unit to make available technical services on a cost recovery basis moving towards full cost recovery in a phased manner, wherever possible
11. Arrange for the periodic audit of ATMA's financial account.
12. Adopt, amend the rules and Bye-laws of the ATMA.
